

## ETFS Long CAD Short EUR

### Investment objective

ETFS Long CAD Short EUR is designed to track the MSFX<sup>SM</sup> Long Canadian Dollar/Euro Index (TR) which aims to reflect movements in exchange rates between the two currencies, plus exposure to local interest rates.

### About the security

ETFS Long CAD Short EUR is a debt security which can be created or redeemed on demand (by authorised participants). It trades on Exchange just like an equity and its pricing and tracking operate similar to an Exchange Traded Fund.

### Collateralisation

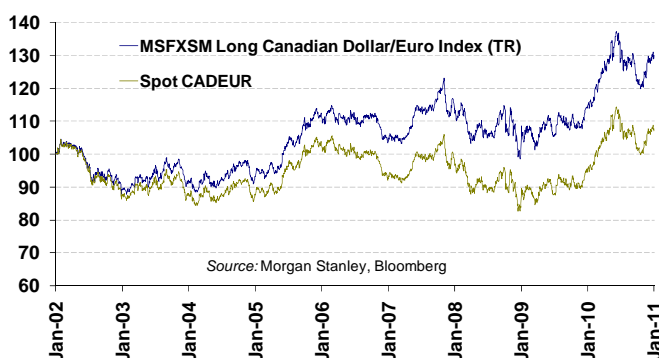
ETFS Long CAD Short EUR is backed by Currency Transactions entered into with a Currency Transaction Counterparty (CTC). Counterparty risk is minimised by way of daily mark to market payments, and cash is used to enter repo transactions with the CTC in exchange for eligible collateral. The eligible collateral is held by the collateral manager BNY Mellon in a custody account and valued daily.

### Key features

- Tracks an index priced off liquid forward contracts
- Provides exposure to foreign exchange movements and local interest rates
- Simple to trade on a major stock exchange
- Settled and held in ordinary brokerage accounts
- Transparent tracking with clear pricing

MSFX<sup>SM</sup> Long Canadian Dollar/Euro Index (TR) is a total return index reflecting the performance of a fully collateralised position in currency forward contracts which are rolled on a daily basis. The index provides long exposure to (i) movements in exchange rates between the local currency (CAD) and EUR and (ii) local interest rates - to the extent either are incorporated in forward contract prices. The Index also provides a Daily Collateral Yield.
